Picnic Area Information

Welcome to Gordon Park. Our staff will make every effort to assist with your event and ensure a great experience for you and your guests. If you have questions or concerns prior to your event contact the Park Manager by phone or email.

Each one of the picnic areas in the park comes with fifteen 8-foot picnic tables and a small charcoal grill. No picnic area has water or electric service.

Picnic Area A2

The A2 Picnic Area is located near the road adjacent to the north parking lot. It is sheltered by mature oak trees and is shaded throughout the day. To reach the nearest restroom and play area you must cross the parking area and travel a paved path to the east side of the park.

Picnic Area A3

The A3 Picnic Area is located near the parking lot and can be accessed from a paved walking trail. This area receives filtered sunlight from mature hardwoods. The area is adjacent to the restroom facilities and play area. This area is on a paved patio and is considered ADA compliant.

Picnic Area A4

The A4 Picnic Area is located near the parking lot in the southeast corner of the park. This area is shaded by a large, mature oak tree. The nearest restroom and play area is located across the parking lot on a short, paved walking trail.

Picnic Rental Rules and Guidelines

- ◆ **Your reservation begins at 7am and ends at sunset.** This includes set-up and packing up time, please plan accordingly. We ask that your area be completely vacated promptly at the end of your rental period and that all trash be disposed of in the provided receptacles.
- ◆ The maximum number of guests allowed is 120.
- ◆ If you plan on paying the fee for amusements/tents/pig roast etc. please call the Park Manager to discuss placement options and needs for your rentals. All rentals must be set up and removed the day of your reservation. They cannot be left overnight unless you have reserved the area again for the following day.
- ◆ There is no vehicle access to any Picnic Area. All coolers/grills/decorations must be brought in by hand from the parking area. Golf carts and ATVs are not allowed to be used on park grounds.
- ◆ When decorating do not use nails, tacks, push-pins, staples, duct tape or anything that will mar or permanently damage tables or trees.
- ◆ No amplified music is allowed in the park.
- ◆ Glitter, confetti, and water balloons are not allowed. Piñatas are allowed but may not be tied to park structures or trees and all debris must be cleaned up.
- ◆ No fires or fireworks of any kind, including sky lanterns, are permitted on park grounds.
- ◆ The restrooms, playgrounds, parking areas are not part of your reservation and are open to the public during park hours.

Please understand that many groups reserve our park areas each season. These rules are in place to ensure that the park will be in good condition for your event and for events in the years to come. Thank you for choosing Gordon Park!
